

RESOLUTION NO. 2019-204

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DISPENSING WITH THE COMPETITIVE BIDDING PROCESS PURSUANT TO ELK
GROVE MUNICIPAL CODE SECTION 3.42.180(B)(3) AND AUTHORIZING THE CITY
MANAGER TO EXECUTE A CONTRACT WITH ARTISTIC HOLIDAY DESIGNS FOR
THE PURCHASE OF AN ARTIFICIAL HOLIDAY TREE IN AN AMOUNT NOT TO
EXCEED \$71,000**

WHEREAS, the City of Elk Grove is creating a new holiday festival experience at the Civic Center that will include a tree lighting on December 7, 2019; and

WHEREAS, Council directed staff to purchase an artificial ribbon tree for this purpose; and

WHEREAS, staff has determined that the proposed artificial ribbon is only sold in the United States by Artistic Holiday Designs with their exclusive manufacturer, Leblanc Illuminations; and

WHEREAS, the City has adequate funding allocated in the FY2019-20 budget for the purchase of the ribbon tree; and

WHEREAS, for the reasons presented, the City Council finds that pursuing a competitive bidding procedure for the purchase of the artificial ribbon tree is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the competitive bidding process pursuant to Elk Grove Municipal Code section 3.42.180(B)(3) and authorizes the City Manager to execute a contract with Artistic Holiday Designs, in substantially the form presented, in an amount not to exceed \$71,000 for the purchase of an artificial ribbon tree for the Civic Center holiday festival.
