

RESOLUTION NO. 2019-234

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE ADDITION OF AN ASSISTANT CHIEF OF POLICE AND
ADJUSTING THE CHIEF OF POLICE SALARY RANGE**

WHEREAS, the City Council recognizes the need for the addition of an Assistant Chief of Police in the Police Department; and

WHEREAS, the Police Chief recommends that this position be authorized to maintain staffing standards; and

WHEREAS, staff evaluated and recommends that the position of the Assistant Chief of Police be placed at approximately 10% above the current Police Captain salary schedule and approximately 5% below the Chief of Police; and

WHEREAS, as a component of including this new position in the salary schedule, the City Council wishes to increase the Chief of Police salary range by 5%.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby approves the addition of an Assistant Chief of Police position at the below salary range and adjusts the Chief of Police salary range as noted below.




