

RESOLUTION NO. 2019-258

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURES
PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.140(B)(3) AND
AUTHORIZING THE CITY MANAGER TO EXECUTE A TWO-YEAR AGREEMENT
WITH “WEAVE” – WOMEN ESCAPING A VIOLENT ENVIRONMENT – FOR A
DOMESTIC VIOLENCE RESPONSE TEAM IN THE AMOUNT OF \$113,044**

WHEREAS, the Elk Grove Police Department (EGPD) has partnered with “WEAVE” – Women Escaping a Violent Environment – to provide victim services and advocacy to the citizens of Elk Grove by means of a Domestic Violence Response Team (DVRT) since 2008; and

WHEREAS, the DVRT has been funded by grants from the U.S. Department of Justice Office on Violence Against Women (OVW) through September 30, 2019; and

WHEREAS, WEAVE is the primary provider of crisis intervention services for survivors of domestic violence and sexual assault in Sacramento County; and

WHEREAS, the City desires to continue the collaborative relationship with WEAVE and will fund the DVRT by utilizing FY 2019/2020 State Supplemental Law Enforcement Services Fund (SLESF) funding, contingent upon Council approval to accept these funds; and

WHEREAS, the City will apply for OVW grant funding for FY 2020 and will use the grant funding for the DVRT, if awarded; and

WHEREAS, in partnership with WEAVE, the City will continue to offer support to and advocacy for victims of domestic violence, dating violence, sexual assault and stalking; and

WHEREAS, the Elk Grove Domestic Violence Response Team will endeavor to break the cycle of violence by pursuing prosecution of those who commit such crimes; and

WHEREAS, for the reasons presented, undergoing a formal request for proposal process for the proposed services is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove finds that a formal request for proposals process is not in the best interest of the City and hereby dispenses with the formal request for proposals procedure, and authorizes the City Manager to execute a two-year agreement with WEAVE, in substantially the form presented, for a Domestic Violence Response Team in the amount of \$113,044.
