

**RESOLUTION NO. 2020-042**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
ACCEPTING THE 2019-2020 CITYWIDE CURB RAMP IMPROVEMENTS [PHASE 1]  
(WAC014) PROJECT AS COMPLETE; AND AUTHORIZING THE CITY ENGINEER  
TO PREPARE AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION  
WITH THE SACRAMENTO COUNTY RECORDER**

**WHEREAS**, on June 26, 2019, the City Council authorized the award of a construction contract to FBD Vanguard Construction, Inc., for the 2019-2020 Citywide Curb Ramp Improvements [Phase 1] (WAC014) Project; and

**WHEREAS**, the Project provided for the construction of Phase 1 of this Project which included 77 ramp replacements at locations throughout the City, 72 of which were ADA curb ramp replacements triggered by the resurfacing improvements for the 2019 Pavement Slurry Seal and Resurfacing Project (WPR019), and funded with Community Development Block Grant (CDBG) funds, with five additional ramps near schools to improve pedestrian accessibility and safety; and

**WHEREAS**, FBD Vanguard Construction, Inc. has completed the work in accordance with the terms and conditions of the contract documents for the Project; and


**WHEREAS**, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to FBD Vanguard Construction, Inc.; and

**WHEREAS**, post construction work is typically completed within one hundred twenty (120) days of the City Clerk filing the Notice of Completion with the Sacramento County Recorder and then all invoices can be paid.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby:

- 1) Accepts the 2019-2020 Citywide Curb Ramp Improvements [Phase 1] (WAC014) Project as complete; and
- 2) Authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder
