**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE AN ASSUMPTION
AGREEMENT WITH CONTINENTAL COLLISION, INC. (FORMERLY JC
AUTOMOBILE REFINISHING, INC.)**

WHEREAS, vehicle body repair and repainting of City-owned vehicles is necessary to delivering service to the citizens of Elk Grove; and

WHEREAS, in November of 2015, the City of Elk Grove (City) entered into a contract with JC Automobile Refinishing, Inc. for vehicle body repair and painting of City-owned vehicles for a three-year term (C-15-522) and amended the contract with a two-year extension in November of 2018 (C-18-688); and

WHEREAS, since the first amendment was signed, JC Automobile Refinishing, Inc. has transferred ownership within the family and renamed the business Continental Collision, Inc.; and

WHEREAS, the City and JC Automobile Refinishing Inc. have agreed to Continental Collision, Inc.'s assumption of the contract; and

WHEREAS, Continental Collision, Inc. has performed the required services to the satisfaction of the City.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute an Assumption Agreement, in substantially the form presented, recognizing the assumption of services originally contracted with JC Automobile Refinishing, Inc. by Continental Collision Inc.
