**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A FUNDING AGREEMENT
WITH THE SACRAMENTO METROPOLITAN CABLE TELEVISION COMMISSION TO
ACCEPT PEG FUNDING IN THE AMOUNT OF \$99,745 AND AMENDING THE
FISCAL YEAR 2020-21 INFORMATION TECHNOLOGY FUND BUDGET TO
REFLECT REVENUE AND EXPENDITURES RELATED TO FUNDS AWARDED**

WHEREAS, the City of Elk Grove (City) received notification that \$99,745 in Public Education and Government (PEG) Channel Facilities fees will be awarded to the City from the Sacramento Metropolitan Cable Television Commission (Metro Cable) for Fiscal Year 2020-21; and

WHEREAS, the City will utilize the funding to replace outdated audio-visual equipment in the Council Chambers; and

WHEREAS, the City will seek reimbursement from Metro Cable after the funds have been expended, but before June 30, 2021.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute the Funding Agreement with the Sacramento Metropolitan Cable Television Commission, in substantially the form presented, accepting Public Education and Government (PEG) Channel Facilities Fees in the amount of \$99,745, and to amend the Fiscal Year 2020-21 Information Technology Fund budget to reflect revenue and expenditures related to funds awarded.
