

RESOLUTION NO. 2021-047

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE ACCEPTING THE BOND ROAD MEDIAN IMPROVEMENTS AND RESURFACING PHASE 2 PROJECT (WTC015) AS COMPLETE; AUTHORIZING THE CITY ENGINEER TO PREPARE AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE SACRAMENTO COUNTY RECORDER; AND AUTHORIZING STAFF TO AMEND THE ANNUAL BUDGET AND CAPITAL IMPROVEMENT PROGRAM BY REDUCING THE REMAINING PROJECT BUDGET AUTHORITY TO ZERO AND RETURNING ANY REMAINING FUNDS BACK TO THEIR RESPECTIVE FUND(S)

WHEREAS, on June 24, 2020, the City Council authorized the award of a construction contract to VSS International, Inc., for the Bond Road Median Improvements and Resurfacing Phase 2 Project (WTC015) (the Project); and

WHEREAS, the Project provided micro-surfacing treatment along Bond Road from East Stockton Boulevard to Elk Grove Florin Road, restriped portions of Bond Road, added new striping, added medians between Elk Crest Drive and Emerald Crest Drive, upgraded several ADA ramps to bring them to current standards, and added video detection at five signalized intersections; and

WHEREAS, Phase 1 of this project was bid and constructed in 2019 and accepted as complete by City Council on January 22, 2020; and

WHEREAS, VSS International, Inc. has completed the work in accordance with the terms and conditions of the contract documents for the Project; and

WHEREAS, if no liens or claims have been filed within 35 days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to VSS International, Inc.; and

WHEREAS, post construction work is typically completed within 120 days of the City Clerk filing the Notice of Completion with the Sacramento County Recorder and then all invoices can be paid.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:


- 1) Accepts the Bond Road Median Improvements and Resurfacing Phase 2 Project (WTC015) as complete;
- 2) Authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder; and
- 3) Authorizes staff to amend the Annual Budget and Capital Improvement Program by reducing the remaining Bond Road Median Improvements and Resurfacing Project (WTC015) budget authority to zero and returning any remaining funds back to their respective fund(s).
