

**RESOLUTION NO. 2021-182**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A MASTER SERVICES  
CONTRACT WITH INTERWEST CONSULTING GROUP, INC. FOR PUBLIC WORKS  
SERVICES FOR FEDERAL AND STATE FUNDED PROJECTS**

**WHEREAS**, the City of Elk Grove utilizes consultants to perform Department of Public Works services; and

**WHEREAS**, the existing master services contracts for Department of Public Works services will expire on June 30, 2021; and

**WHEREAS**, a continuation of Department of Public Works Services is vital to the completion of current public works projects and a lapse of having a contract for these services is unacceptable; and

**WHEREAS**, the City has followed federal and state regulations, as well as requirements of the City's purchasing ordinance by issuing a Request for Qualifications to solicit these services (one contract for locally funded work and the other contract for state and federally funded work) and received proposals on January 22, 2021; and

**WHEREAS**, Interwest Consulting Group, Inc.'s Statement of Qualifications met all of the requirements of the Request for Qualifications and is best suited to meet the City's needs and staff has negotiated fair and reasonable contract terms with Interwest Consulting Group, Inc.; and

**WHEREAS**, on May 26, 2021, City Council authorized the City Manager to execute the first Master Services contract with Interwest Consulting Group, Inc. for locally funded Public Works Services; and

**WHEREAS**, On May 27, 2021, the California Department of Transportation (Caltrans) completed a review of the federal and state funded Public Works Services contract and there were no changes as a result of this review.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a Master Services contract with Interwest Consulting Group, Inc., in substantially the form presented, to provide Department of Public Works Services for federal and state funded projects to the City of Elk Grove.


