

**RESOLUTION NO. 2021-183**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY ENGINEER TO REJECT ALL BIDS FOR THE 2021  
PAVEMENT SLURRY SEAL AND RESURFACING PROJECT (WPR021) AND  
DIRECTING THE CITY ENGINEER TO RE-BID THE PROJECT, OR TAKE  
ALTERNATIVE ACTION AS DEEMED APPROPRIATE**

**WHEREAS**, the 2021 Pavement Slurry Seal and Resurfacing Project (WPR021) (Project) will result in the following: place slurry seal, micro-surfacing, multi-layer treatment system, repair asphalt pavement, and stripe various streets throughout the City, as shown on the location maps presented to Council: and

**WHEREAS**, the Project was posted on the City of Elk Grove Vendor Portal through PlanetBids on May 4, 2021, and the call for bids was advertised on May 7, 2021, and May 14, 2021, and electronic bids were received on June 1, 2021; and

**WHEREAS**, on June 1, 2021, after review of the bids received, staff has determined that VSS International, Inc., Intermountain Slurry Seal, Inc., and Dryco Construction, Inc. failed to submit original hard copies of either or both, the bid bond and/or noncollusion declaration documents; therefore, determination was made that three of the four bidders were non-responsive; and

**WHEREAS**, it is in the City's best interest to reject all bids and re-bid the Project; and

**WHEREAS**, the Project is included in the approved Fiscal Year 2020-25 Capital Improvement Program and is budgeted with funds in the approved Fiscal Year 2020-21 Budget.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby:

- 1) Authorizes the City Engineer to reject all bids received on June 1, 2021, for the 2021 Pavement Slurry Seal and Resurfacing Project (WPR021); and
- 2) Directs the City Engineer to re-bid the Project with any necessary revisions to the bid package




