

RESOLUTION NO. 2021-291

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE FINDING CONDITIONS TO CONTINUE USE OF TELECONFERENCE MEETINGS AND REVIEWING THE LOCAL EMERGENCY PROCLAMATION

WHEREAS, on March 13, 2020, the City Manager (acting as the Director of Emergency Services) adopted a Resolution Proclaiming Existence of Local Emergency (Local Emergency Proclamation), which Local Emergency Proclamation was ratified by the City Council on March 18, 2020, and remains in effect; and

WHEREAS, the City of Elk Grove (City) has been utilizing teleconference meetings for its legislative bodies since March 18, 2020, after the Proclamation of a State of Emergency was declared by the California Governor on March 4, 2020, in response to the COVID-19 pandemic; and

WHEREAS, use of teleconference meetings was facilitated by executive orders issued by the Governor that relaxed state regulations related to holding teleconference meetings, and similar provisions were enacted by Assembly Bill 361; and

WHEREAS, California Government Code Section 54953(e)(3), as amended by Assembly Bill 361, requires that the City Council make specific findings to continue the use of teleconference meetings in the format permitted under state law during a state of emergency; and

WHEREAS, the statewide State of Emergency remains in effect; and

WHEREAS, on July 29, 2021, the Sacramento County Public Health Officer issued a public health order that requires individuals to wear a face covering indoors in the workplace and other public settings regardless of vaccination status; and

WHEREAS, that Sacramento County health order remains in effect, and with the continued requirement for face coverings indoors, the City Council has opted to utilize teleconferencing for public meetings.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Elk Grove that:


- 1) Pursuant to Government Code section 54953(e)(3), the City Council has reconsidered the circumstances of the State of Emergency and finds: (i) the state of emergency continues to directly impact the ability of the members to meet safely in person; and (ii) state or local officials continue to impose or recommend measures to promote social distancing; and
- 2) The City Council chooses to continue to conduct meetings by teleconference without compliance with the provisions of California Government Code Section 54953(b)(3) to facilitate continued use of teleconference meetings, all as authorized by California Government Code section 54953(e); and
- 3) The City Council will reconsider the circumstances of the State of Emergency and use of teleconferencing within the next 30 days; and
- 4) The City Council takes no action at this time to terminate or alter the Local Emergency Declaration.


