

**RESOLUTION NO. 2021-313**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE AN ASSUMPTION AND  
ASSIGNMENT AGREEMENT WITH CASTLE TIRE DISPOSAL, LLC, FOR  
TRANSPORTATION AND RECYCLING OF USED TIRES AS PREVIOUSLY  
APPROVED UNDER CONTRACT NO. C-18-442 AND CONTRACT AMENDMENT  
NO. C-21-189 WITH TRI-C MANUFACTURING, INC.**

**WHEREAS**, transportation and recycling of used tires is a necessary service to the residents of Elk Grove in that it aids in the reduction of illegal dumping; and

**WHEREAS**, in July of 2018, the City of Elk Grove (City) entered into a contract with Tri-C Manufacturing, Inc. (Contract No. C-18-442) for the transportation and recycling of used tires collected during the City's monthly tire collection events and amended the contract with a one-year extension in May 2021 (Contract No. C-21-189); and

**WHEREAS**, since the contract was signed, Tri-C Manufacturing, Inc. has been acquired by Castle Tire Disposal, LLC, and all services previously performed by Tri-C Manufacturing, Inc. will now be performed by Castle Tire Disposal, LLC; and

**WHEREAS**, the City and Tri-C Manufacturing, Inc. have agreed to Castle Tire Disposal, LLC's assumption of the contract.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute an Assumption and Assignment Agreement with Castle Tire Disposal, LLC, in substantially the form presented, for transportation and recycling of used tires as previously approved under Contract No. C-18-442 and amendment C-21-189 with Tri-C Manufacturing, Inc.
