WHEREAS, on December 9, 2015, City Council adopted a Resolution (2016-031) electing to become subject to the California Uniform Public Construction Cost Accounting Procedures (UPCCAA). The UPCCAA Policy authorizes the City Manager to award projects that do not exceed \$175,000; and

WHEREAS, on October 14, 2016, the City Manager awarded the Office Construction (WFC010) and Service Center Ballistic Panel Install and Entrance Door Replacement (WFC009) Projects contract to Northern Pacific Builders, Inc.; and

WHEREAS, the Project constructed two private offices within an existing open office area in the 8401 Laguna Palms Way building; and furnished and installed a ballistic panel fortification to existing counter millwork and replaced the interior door at the 8400 Laguna Palms Way building; and

WHEREAS, Northern Pacific Builders, Inc. has completed the work in accordance with the terms and conditions of the contract documents for the Project; and

WHEREAS, if no liens or claims have been filed within thirty-five (35) days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Northern Pacific Builders, Inc.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Office Construction (WFC010) and Service Center Ballistic Panel Install and Entrance Door Replacement (WFC009) Projects as complete; and

**BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.
