

**RESOLUTION NO. 2022-134**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE CREDIT REIMBURSEMENT  
AGREEMENTS WITH REYNEN & BARDIS CONSTRUCTION, LLC,  
FOR PRIVATELY CONSTRUCTED PUBLIC FACILITIES INCLUDED IN THE ELK  
GROVE SOUTHEAST POLICY AREA AND LAGUNA RIDGE PHASE 3 DRAINAGE  
IMPACT FEE PROGRAM AND CONSTRUCTED FOR THE BENEFIT OF THE SOUZA  
DAIRY UNIT 6 AND SOUZA DAIRY UNIT 7 PROJECTS**

**WHEREAS**, Elk Grove Municipal Code Section 16.95.070 provides for reimbursement to developers for the private construction of any facilities designated in the Elk Grove Southeast Policy Area and Laguna Ridge Phase 3 Drainage Impact Fee Program subject to entering into a reimbursement agreement with the City of Elk Grove (City); and

**WHEREAS**, Reynen & Bardis Construction, LLC, is constructing drainage improvements in the North Sub-Shed Basin, which is located in the City's Southeast Policy Area and these improvements are identified in the Elk Grove Southeast Policy Area and Laguna Ridge Phase 3 Drainage Impact Fee Program as eligible for reimbursement in the form of fee credits.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute two Credit Reimbursement Agreements with Reynen & Bardis Construction, LLC, in substantially the forms presented, for reimbursement by way of credits against future fees from the Elk Grove Southeast Policy Area and Laguna Ridge Phase 3 Drainage Impact Fee Program as follows:
