

RESOLUTION NO. 2022-159

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A MASTER SERVICES
CONTRACT WITH DOKKEN ENGINEERING TO PROVIDE ON CALL
ENVIRONMENTAL SERVICES FOR LOCALLY FUNDED PROJECTS IN AN AMOUNT
NOT TO EXCEED \$3,000,000 OVER THE TERM OF THE CONTRACT**

WHEREAS, the City of Elk Grove (City) utilizes consultants to perform services within the Department of Public Works including environmental services; and

WHEREAS, the existing master services contracts for environmental services will expire on July 26, 2022; and

WHEREAS, a continuation of environmental services is vital to the completion of public works projects and a lapse of having a contract for these services is unacceptable; and

WHEREAS, the City has followed federal and state regulations as well as the City's purchasing ordinance requirements by issuing a Request for Qualifications to solicit these services (one contract for locally funded work and the other contract for state and federally funded work) and received proposals on March 17, 2022; and

WHEREAS, Dokken Engineering's statement of qualification met all of the requirements of the Request for Qualifications and is best suited to meet the City's needs and staff has negotiated fair and reasonable contract terms.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a master services contract with Dokken Engineering, in substantially the form presented, to provide On Call Environmental Services for locally funded projects for a term of three years with two optional one year extensions in an amount not to exceed \$3,000,000 over the term of the agreement and authorizes the City Manager to execute the extensions.
