

**RESOLUTION NO. 2023-142**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURE  
PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.140(B)(3) AND  
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH MCELROY  
TECHNOLOGY SOLUTIONS FOR CONSULTING SERVICES RELATED TO  
AUTOMATION OF THE CITY'S BUDGET DOCUMENT AND TO ENHANCE  
FINANCIAL REPORTING TOOLS FOR A TERM OF FIVE YEARS IN AN AMOUNT  
NOT TO EXCEED \$93,409**

**WHEREAS**, since 2015, the City of Elk Grove (City) has contracted with McElroy Technology Solutions to automate the City's budget document development process, and both maintain and enhance financial reporting tools for the City; and

**WHEREAS**, McElroy Technology Solutions has streamlined many reports for the annual budget document and reduced manual data entry significantly; and

**WHEREAS**, the City has an ongoing need for budget book automation software and financial reporting enhancements; and

**WHEREAS**, for the reasons presented, compliance with the formal request for proposal process for seeking a provider for budget automation and reporting services is not in the best interest of the City.


**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby dispenses with the formal request for proposal procedure pursuant to Elk Grove Municipal Code Section 3.42.140(B)(3) and authorizes the City Manager to execute a contract with McElroy Technology Solutions, in substantially the form presented, for Consulting Services related to automation of the City's budget document and to enhance financial reporting tools for a term of five years in an amount not to exceed \$93,409.
