

RESOLUTION NO. 2023-171

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURES
PURSUANT TO ELK GROVE MUNICIPAL CODE CHAPTER 3.42.140(B)(3) AND
AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH
PINNACLE TRAINING SYSTEMS, LLC FOR LAW ENFORCEMENT WELLNESS
HEALTH SCREENINGS FOR A TOTAL NOT-TO-EXCEED AMOUNT OF \$80,000**

WHEREAS, law enforcement is a high-stress, physically taxing career often resulting in health implications for police officers; and

WHEREAS, it is critical to take preventative measures to ensure police officers can perform their job safely and effectively; and

WHEREAS, police officer health screenings are one preventative measure that brings awareness to employees, providing them with information that helps them avoid injury and prevent future health conditions; and

WHEREAS, the City of Elk Grove was awarded grant funding for officer wellness and mental health resources from the Board of State and Community Corrections to be used for the purpose of improving officer wellness and expanding mental health resources; and

WHEREAS, City staff desires to use the grant funding to cover the cost of police officer wellness screenings; and

WHEREAS, staff conducted a search and found that Pinnacle Training Systems, LLC is the only provider with the requisite experience in specialized law enforcement health screenings able to perform screenings that meet the needs of the Department onsite at Elk Grove Police Department; and

WHEREAS, pursuant to Elk Grove Municipal Code Sections 3.42.140(B)(3), the City Council may dispense with the formal request for proposals procedure when, in the judgment of the City Council, compliance with the procedure is not in the best interest of the City.


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby finds that a formal request for proposals process is not in the best interest of the City, dispenses with the formal request for proposal procedure pursuant to Elk Grove Municipal Code Section 3.42.140(B)(3), and authorizes the City Manager to execute an agreement with Pinnacle Training Systems, LLC, in substantially the form presented, for law enforcement wellness health screenings in an amount not to exceed \$80,000.
