The nomination periods for Mayor and Council District 1 closed August 7, and Council District 3 closed at 5:00 p.m. on Wednesday, August 12, 2020. The Randomized Alphabet Drawing was conducted by the California Secretary of State on **August 13, 2020 at 11:00 a.m.** The [randomized alphabet drawing](#) determines the order in which candidates' names will appear on the ballot.

The Nomination Period for Write-in Candidates commenced September 8, 2020 and closed October 20, 2020.
