RECOMMENDED ACTION:

Staff recommends that the City Council adopt a resolution dispensing with competitive bidding and authorizing the City Manager to execute a Memorandum of Understanding with the County of Sacramento for the purchase of replacement police radio equipment in an amount not to exceed \$895,219 over 10 years.

BACKGROUND INFORMATION:

In 1994, the Sacramento County Regional Radio Communications System (SRRCS) implemented a Motorola SmartNet Trunked Radio System. The system provided law enforcement radio coverage to over 1,000 square miles for Sacramento County and parts of Yolo County. Since that time, upgrades and modifications to the system have taken place in an effort to maintain updated system technology as well as to fulfil the needs of the SRRCS member agencies.

In February 2013, SRRCS began transitioning from its current 4.1 Motorola SmartZone radio system to a new Project 25 compliant (P25 or APCO-25) system. This transition is expected to be completed by October 2019. SRRCS started transitioning to the new P25 radio system for the following reasons:

- Transition from analog to digital radios by most users, including public safety, is a requirement of the Federal Communications Commission. Eventually, all radios will need to be transitioned to P25 or APCO-25 systems.
- 2. Technical support will no longer be available for the current system starting in 2013.
- 3. Repairs on components of the radios will be with spare parts estimated to last until 2019.
- 4. Other key components of the radio system will cease to be supported starting in 2017.

On December 11, 2012, the Sacramento County Board of Supervisors approved a resolution to sign a contract with Motorola Solutions to begin the phased replacement of the current 4.1 system. The current 4.1 SRRCS system is an analog system. About 40% of the law enforcement radios operating on this radio system are analog radios, including Elk Grove. These radios where purchased in 1996 and are no longer supported. Analog radios will not be able to use the digital P25 system.

Through a series of negotiations, Motorola has offered SRRCS a 40% discount off the suggested retail price for replacement radios. Motorola will also finance these replacement radios via a ten-year municipal lease-purchase for all participating law enforcement agencies.

As a participating SRRCS member agency, the City of Elk Grove's Police Department will receive replacement radios from the County of Sacramento under this program. The County will be responsible for making annual lease payments to Motorola when they are due; however, the City of Elk Grove will be responsible for payment to the County for the equipment it receives.

The term of this municipal lease purchase will be ten years. The first payment will be due and payable on July 1, 2014. Subsequent payments are due on July 1 of each year, and the final payment will be due on July 1, 2023.

Based on the total equipment purchase of \$895,219, the annual lease payment will be \$107,860. If approved, this purchase shall be made pursuant to Elk Grove Municipal Code Section 3.42.180(B)(3), which provides an exception to the competitive bidding process when compliance with the procedure is not in the best interest of the City for those commodities, equipment or general services. Staff feels that purchasing this equipment through the County without competitive bidding is in the City's best interest. SRRCS has set a standard for the model and type of radio that can be operated on its system. As a participating agency of SRRCS, the City of Elk Grove is required to follow that standard. If the City of Elk Grove was to negotiate the purchase of these standardized radios separate from the County, pricing would likely be significantly higher.

FISCAL IMPACT:

The FY 2014-15 budget will include an annual payment, and future budgets will include required annual payments. Total payments will not exceed the contract maximum.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH COMPETITIVE BIDDING AND AUTHORIZING THE CITY MANAGER TO EXECUTE A MEMORANDUM OF UNDERSTANDING WITH THE COUNTY OF SACRAMENTO FOR THE PURCHASE OF REPLACEMENT POLICE RADIO EQUIPMENT IN AN AMOUNT NOT TO EXCEED \$895,219.19 OVER 10 YEARS

- WHEREAS, the Sacramento County Regional Radio Communications System (SRRCS) oversees the use of law enforcement radio systems in Sacramento County; and
- **WHEREAS**, all law enforcement agencies in Sacramento County are members of SRRCS and must comply with its established radio communications standards; and
- **WHEREAS**, SRRCS started transitioning to a new radio system due to the pending obsolescence of the current system; and
- **WHEREAS**, the County of Sacramento Board of Supervisors approved a resolution to sign a contract with Motorola Solutions to begin the phased replacement of the current system; and
- **WHEREAS**, as a participating agency, the City of Elk Grove's Police Department will receive replacement radios from the County of Sacramento under this program; and
- **WHEREAS**, the County will be responsible for making annual lease payments to Motorola when they are due; however, the City of Elk Grove will be responsible for payment to the County for the equipment it receives; and
- **WHEREAS**, the term of this municipal lease purchase will be ten years with the first payment due and payable on July 1, 2014; and
- **WHEREAS**, the total cost of replacing the City of Elk Grove's law enforcement radios is \$895,219.19, the annual payment for which is included in the FY 2014-15 budget and will be included in future budgets; and
- **WHEREAS**, the City Council may dispense with competitive bidding under the Elk Grove Municipal Code, where, as here, in the determination of Council, compliance with the procedure is not in the best interest of the City for those commodities, equipment, or general services.
- **NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby dispenses with competitive bidding and authorizes the City Manager to execute a Memorandum of Understanding with the County of Sacramento for the purchase of replacement police radio equipment in an amount not to exceed \$895,219.19 over 10 years.

THIS AGREEMENT is made and entered into as of this _____day of April, 2014, by and between the COUNTY OF SACRAMENTO, hereinafter referred to as the "County", and the CITY OF ELK GROVE, herein referred to as "Elk Grove".

RECITALS

- A. Beginning in 1994 the Sacramento Regional Radio Communications System (SRRCS) implemented a Motorola SmartNet Trunked Radio System. The system provided radio coverage to over 1,000 square miles for Sacramento County and parts of Yolo County.
- B. Since that time upgrades and modifications to the system have taken place in an effort to maintain updated system technology as well as fulfilling the needs of the SRRCS individual member agencies.
- C. In February of 2013, SRRCS began transitioning from their current 4.1 Motorola SmartZone radio system to a new Project 25 (P25 or APCO-25) system. This transition should be completed by October 2019. Some of the reasons why SRRCS started transitioning to the new P25 radio system included the following:
 - > Technical support will no longer be available for the current system starting in 2013.
 - > Repairs on components of the Master Site Equipment (SmartZone) will be best effort with spare parts estimated to last until 2019.
 - ➤ Other key components of the Trunked radio system will fall out of support starting in 2017.
- D. On December 11, 2012, the Sacramento County Board of Supervisors approved a resolution to sign a contract with Motorola Solutions to begin the phased replacement of the current 4.1 system.
- E. The current 4.1 SRRCS system is an analog system. About 40% of the radios operating on this radio system are analog radios. These radios where purchased in 1996 and are no longer supported. Analog radios will not be able to use the digital P25 system.
- F. Through a series of negotiations, Motorola has offered SRRCS a 40% discount off the suggested retail price for replacement radios. They will also finance these replacement radios via a 10 year municipal lease-purchase.

1. SCOPE OF SERVICE

- a. The County will be responsible for making annual lease payments to Motorola when they are due.
- b. Starting on August 1, 2015, the County will provide an annual lease activity report to Elk Grove. This activity report will contain the amount financed, all payments made, and the remaining amount owed.

2. EQUIPMENT DELIVERY

- a. All radios and assessories will be delivered directly to the County radio shop located at 3700 Branch Center Road, in Sacramento.
- b. The Elk Grove Police Department (Elk Grove PD) will be responsible for arranging the deliverery of equipment from the County radio shop to their location. The Elk Grove PD will be solely responsible for any equipment loss while in transit to their location.
- c. Prior to taking delivery of their equipment purchases Elk Grove PD and SRRCS staff will verify amounts (and condition) of equipment actually received to packing slips.

3. LEASE TERMS AND PAYMENTS

- a. The term of this municipal lease purchase will be 10 years. The first payment will be due and payable on July 1, 2014. Subsequent payments are due on July 1, and the final payment will be due on July 1, 2023. Please see Appendix A (amortization schedule) for specific payment details.
- b. The annual interest rate for this lease purchase will be 3.54%, and the total cost of the lease is \$1,078,595.10.
- c. Based on the total equipment purchased of \$895,219.19 (Appendix B), Elk Grove's annual lease payment will be \$107,859.51.
- d. With a 30 day notice, Elk Grove may make a lump sum payment to payoff any outstanding balances due on this obligation without paying additional penalities or early retirement fees.
- e. SRRCS will invoice Elk Grove for their annual payment on this obglation by June 30 until the final payment is made.
- f. Annual payments will be made in accordance with the information provided on the SRRCS invoice.

4. COMPLIANCE WITH LAWS

Elk Grove and the County shall observe and comply with all applicable Federal, State, County and City laws, regulations and ordinances.

5. GOVERNING LAWS AND JURISDICTION

This Agreement shall be deemed to have been executed and to be performed within the State of California and shall be construed and governed by the internal laws of the State of California. Any legal proceedings arising out of or relating to this Agreement shall be brought in Sacramento County, California.

6. CONFLICT OF INTEREST

Elk Grove and the County officers and employees shall not have a financial interest, or acquire any financial interest, direct or indirect, in any business, property or source of income that could be financially affected by or otherwise conflict in any manner or degree with the performance of services required under this Agreement.

7. TERMINATION

The agreement can be terminated by Elk Grove by either paying any outstanding amounts owned, or after the final payment due on July 1, 2023.

8. OWNERSHIP, MAINTENANCE, AND DISPOSAL OF EQUIPMENT

At the completion of this agreement Elk Grove will have full ownership of the equipment purchased. Elk Grove will be solely responsible for ongoing maintenance and disposal of all equipment purchased under this agreement.

9. AMENDMENTS

No alternation, amendment, variation or waiver of terms of this agreement shall be valid unless in made in writing and signed by all parties.

10. NOTICE

Any notice, demand, request, consent, or approval that either party hereto may or is required to give the other pursuant to this Agreement shall be in writing and shall be either personally delivered or sent by mail, addressed as follows:

Either party may change the address to which subsequent notice and/or other communications can be sent by giving written notice designating a change of address to the other party, which shall be effective upon receipt.

11. INTERPRETATION

This Agreement shall be deemed to have been prepared equally by both of the parties, and the Agreement and its individual provisions shall not be construed or interpreted more favorably for one party on the basis that the other party prepared it.

12. ENTIRE AGREEMENT

For The County

This Agreement constitutes the entire contract between Elk Grove and the County regarding the subject matter of this Agreement. Any prior agreements, whether oral or written, between Elk Grove and the County regarding the subject matter of this Agreement are hereby terminated effective immediately upon full execution of this Agreement.
