NOTICE IS HEREBY GIVEN that on **March 26, 2008, at 6:00 p.m.**, or as soon thereafter as the matter may be heard, the City Council of the City of Elk Grove will hold a Public Hearing at the **Elk Grove City Hall, located at 8400 Laguna Palms Way, Elk Grove**, to consider the following actions:

CONSIDERATION OF THE 2008-2013 CONSOLIDATED PLAN AND THE 2008-2009 ACTION PLAN

The Consolidated Plan describes the City's five-year needs, goals and objectives for the use of federal Community Development Block Grant funds; the Action Plan identifies the proposed use of the 2008-09 allocation of these funds within the five-year Consolidated Plan cycle.

The release of this document is part of the City's efforts to fulfill federal Consolidated Plan citizen participation requirements to provide the public with reasonable access to the documents associated with the implementation of the Consolidated Plan. Per federal requirements, the public will have 30 days in which to comment on the Consolidated Plan and Action Plan before its consideration and approval by the Elk Grove City Council. All comments received in writing will be responded to in writing and will be included in the plan for its submittal to the Department of Housing and Urban Development (HUD).

The Consolidated Plan and Action Plan are available for public review at the Elk Grove City Hall, 8401 Laguna Palms Way; the Elk Grove Public Library, 8962 Elk Grove Boulevard; and the Elk Grove Senior Center, 8830 Sharkey Avenue. The plans are also available for public review on the City Planning Division's website at www.egplanning.org/cdbg.html.

Copies of the plans will be made available upon request and are free of charge.

The public review and comment period begins March 26, 2008 and will end April 26, 2008. The City of Elk Grove City Council will consider adoption of the Consolidated Plan and Action Plan and will provide an opportunity for public comment at their April 23, 2008 meeting.

Information regarding this item may be obtained in the office of the Development Services Department, 8401 Laguna Palms Way, Elk Grove, California. All interested persons are invited to present their views and comments on this matter. Written

statements may be filed with the City Clerk at any time prior to the close of the hearing scheduled herein, and oral statements may be made at said hearing.

If you challenge the subject matter in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice or in written correspondence delivered to the City Clerk, 8380 Laguna Palms Way, Suite 200 Elk Grove, CA, 95758, at or prior to the close of the public hearing.
