## **City of Elk Grove – City Council NOTICE OF PUBLIC HEARING**

**NOTICE IS HEREBY GIVEN** that on **Wednesday, September 10, 2008 at the hour of 6:00 p.m.**, or as soon thereafter as the matter may be heard, the Elk Grove City Council will conduct a public hearing at City Hall in the Council Chambers, 8400 Laguna Palms Way, Elk Grove, California, to consider the following matter:

### **CONSIDERATION AND APPROVAL OF THE 2007-2008 CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT (CAPER)**

The CAPER describes the City of Elk Grove's accomplishments during the 2007-08 Fiscal Year in its implementation of programs and activities under the Community Development Block Grant (CDBG) program. It also reports the progress of the City in meeting overall five-year Consolidated Plan goals and priorities, as well as identifying areas for improvement as a result of this annual review. The CAPER provides a summary of accomplishments for each activity that was proposed in the 2007-08 Action Plan, how those activities contributed to the City's efforts to meet identified five-year goals, as well as a description of the City's actions to affirmatively further fair housing, foster efforts and eliminate barriers to affordable housing, support and participate in the Continuum of Care to serve the homeless, reduce lead-based paint hazards, enhance coordination with service providers, and assist persons and families to reduce poverty. The CAPER also describes funds that were leveraged during the year to assist with housing and community development goals, as well as a self-evaluation of the City's efforts and strategies for improvement.

The release of this document is part of the City's efforts to fulfill federal Consolidated Plan citizen participation requirements to provide the public with reasonable access to the documents associated with the implementation of the Consolidated Plan, including the CAPER. Per federal requirements, the public will have 15 days in which to comment on the CAPER before its consideration and approval by the Elk Grove City Council. All comments received in writing will be responded to in writing and will be included in the CAPER for its submittal to the Department of Housing and Urban Development (HUD).

The CAPER is available for public review at the Elk Grove City Hall, 8401 Laguna Palms Way; the Elk Grove Public Library, 8962 Elk Grove Boulevard; and the Elk Grove Senior Center, 8830 Sharkey Avenue. The CAPER is also available for public review on the City Planning Division's website at [www.egplanning.org/cdbg.html](http://www.egplanning.org/cdbg.html).

Copies of the CAPER will be made available upon request and are free of charge.

The public review and comment period begins August 27, 2008 and will end September 10, 2008. The City of Elk Grove City Council will consider adoption of the CAPER and provide an opportunity for public comment at their September 10, 2008 meeting.
