NOTICE is hereby given pursuant to section 65090 and 65091 of the California Government Code that on **September 23, 2009, at 6:00 p.m.**, or as soon thereafter as the matter may be heard, the City Council of the City of Elk Grove will hold a Public Hearing at the **Elk Grove City Hall, located at 8400 Laguna Palms Way, Elk Grove, CA** to consider the following actions:

CONSIDERATION AND APPROVAL OF THE 2008-09 CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT (CAPER)

The purpose of this public hearing is to consider the adoption of the 2008-09 Consolidated Annual Performance and Evaluation Report (CAPER) for the Community Development Block Grant (CDBG) program. The 2008-09 CAPER describes the programs and activities accomplished during the 2008-09 program year, in which the City received \$492,958 in federal CDBG funds.

The release of this notice is one of the City's activities to fulfill citizen participation requirements. Federal regulations require localities to provide the public with reasonable access to the documents.

The CAPER is available for public review at the Elk Grove City Hall, 8401 Laguna Palms Way; the Elk Grove Public Library, 8900 Elk Grove Boulevard; and the Elk Grove Senior Center, 8830 Sharkey Avenue. The CAPER is also available for public review on the City Planning Division's website at www.egplanning.org/cdbg.html.

Copies of the CAPER will be made available upon request and are free of charge.

The public review and comment period begins September 8, 2009 and will end September 23, 2009. The City of Elk Grove City Council will consider adoption of the CAPER and provide an opportunity for public comment at their September 23, 2009 meeting.

The City of Elk Grove encourages interested parties to attend public meetings and comment on the issues being discussed. If you wish to provide testimony and are unable to attend the meeting, written comments that are delivered to the City Clerk's office prior to the time of the hearing will be made a part of the public record.
