NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that on **Wednesday, November 18, 2009** at the hour of **6:00 p.m.**, or as soon thereafter as the matter may be heard, the Elk Grove City Council will conduct a public hearing at City Hall in the Council Chambers, 8400 Laguna Palms Way, Elk Grove, California, to consider the following actions:

APPROVAL OF THE SUBSTANTIAL AMENDMENT TO THE 2008-09 COMMUNITY DEVELOPMENT BLOCK GRANT ACTION PLAN AND AMENDMENT TO THE 2009-10 COMMUNITY DEVELOPMENT BLOCK GRANT ACTION PLAN

The 2009-10 Community Development Action Plan allocated \$282,281 to a public facility project with preference to the creation of a one-stop services center. In addition, the Substantial Amendment to the 2008-09 Community Development Block Grant (CDBG) Action Plan allocated \$133,902 in CDBG funds received through the American Recovery and Reinvestment Act to the creation of a one-stop services center. Due to events since, such as problems with additional funding, tenants, and timing, the City now plans use the funds to complete four public facility projects. These are:

1. Elk Grove Adult Community Training (EGACT) facility upgrades;
2. Senior Center of Elk Grove (SCEG) facility upgrades;
3. Elk Grove Food Bank facility improvements; and
4. Pedestrian/bike trail paving near Elk Grove Creek and Markofer Elementary School.

The release of this notice is part of the City's activities to fulfill federal citizen participation requirements. The Action Plan amendments must be available to the public and the City must provide reasonable access to documents.

The Action Plan amendments will be available for public review at the Elk Grove City Hall, 8401 Laguna Palms Way; the Elk Grove Public Library, 8900 Elk Grove Boulevard; and the Elk Grove Senior Center, 8830 Sharkey Avenue. The Action Plan amendments will also be available for public review on the City's Planning Division website at <http://www.egplanning.org/misc/cdbg>.

Copies of the Action Plan amendments will be made available upon request and are free of charge. The Action Plan amendment is available in Spanish upon request.

The public review and comment period begins October 19, 2009 and will end November 18, 2009.
