NOTICE IS HEREBY GIVEN that on **Wednesday, November 18, 2009 at the hour of 6:00 p.m.**, or as soon thereafter as the matter may be heard, the Elk Grove City Council will conduct a public hearing at City Hall in the Council Chambers, 8400 Laguna Palms Way, Elk Grove, California, to consider the following matter:

Hearing to adopt resolutions (1) approving abandonments in the vicinity of the Grant Line Road/SR 99 Interchange of: portions of East and West Stockton Boulevard, portions of CMD Court (now East Stockton Boulevard), a Slope Easement, Public Utility Easements, and an Irrevocable Offer of Dedication; (2) setting aside a portion of City-owned property for public street and Public Utility Easement purposes; and (3) quitclaiming a portion of the aforementioned East Stockton Boulevard to Elk Grove V Partners, LLC.

Request: The project consists of the vacation of portions of East Stockton Boulevard and , CMD Court (Now East Stockton Boulevard), Vacation of Public Utility Easements and Setting - aside a portion of City owned property for Public Street and Utility Purposes in conjunction with the Grant Line Interchange.
