NOTICE IS HEREBY GIVEN that on **Wednesday, May 26, 2010 at the hour of 6:00 p.m.**, or as soon thereafter as the matter may be heard, the Elk Grove City Council will conduct a public hearing at City Hall in the Council Chambers, 8400 Laguna Palms Way, Elk Grove, California, to consider the following matter:

ADOPTION OF THE DRAFT 2010-11 COMMUNITY DEVELOPMENT BLOCK GRANT ACTION PLAN

The 2010-2011 Action Plan describes the programs and activities proposed for funding during the 2010-2011 program year. The City anticipates receiving CDBG funding of about \$500,000, and will reallocate about \$92,500 in prior-year funds. During the program year that begins July 1, 2010, the City plans to fund housing, public facilities improvements, community services, and program administration.

The release of this notice is part of the City's activities to fulfill federal Consolidated Plan citizen participation requirements. The Action Plan must be available to the public and the City must provide reasonable access to documents.

The Action Plan will be available for public review at the Elk Grove City Hall, 8401 Laguna Palms Way; the Elk Grove Public Library, 8900 Elk Grove Boulevard; and the Elk Grove Senior Center, 8830 Sharkey Avenue. The Consolidated Plan and Action Plan, as well as links to data and resource information used in development of these documents, will also be available for public review on the City's Planning Division website at <http://www.egplanning.org/misc/cdbg>.

Copies of the Action Plan will be made available upon request and are free of charge.

The public review and comment period begins April 28, 2010 and will end May 27, 2010. The City of Elk Grove City Council will consider adoption of the Action Plan and provide an opportunity for public comment at their May 26, 2010 meeting.

Information regarding this item may be obtained in the office of the Planning Department-Housing Division at 8401 Laguna Palms Way, Elk Grove, CA. All interested persons are invited to present their views and comments on this matter. Written statements may be filed with the City Clerk at any time prior to the close of the hearing scheduled herein, and oral statements may be made at said hearing.

If you challenge the subject matter in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice or in written correspondence delivered to the City Clerk, 8401 Laguna Palms Way, 1st Floor, Elk Grove, CA, 95758, at or prior to the close of the public hearing.
