NOTICE is hereby given pursuant to section 65090 and 65091 of the California Government Code that on **September 08, 2010, at 6:00 p.m.**, or as soon thereafter as the matter may be heard, the City Council of the City of Elk Grove will hold a Public Hearing at the **Elk Grove City Hall, located at 8400 Laguna Palms Way, Elk Grove**, to consider the following actions:

CONSIDERATION AND APPROVAL OF THE 2009-10 CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT (CAPER)

The purpose of this public hearing is to consider the adoption of the 2009-10 Consolidated Annual Performance and Evaluation Report (CAPER) for the Community Development Block Grant (CDBG) program. The 2009-10 CAPER describes the programs and activities accomplished during the 2009-10 program year, in which the City received \$500,738 in federal CDBG funds. The programs and activities that were conducted during the 2009-10 program year include, but are not limited to, Meals on Wheels for seniors, Congregate Meals for seniors, Fair Housing Counseling, Homeless Prevention Counseling and Referral, and Support Works for Women counseling and referral. In addition, public facility improvement projects that were funded during the 2009-10 program year include a new driveway and ADA accessible ramps at the Elk Grove Adult Community Training (EGACT) Facility, various improvements to the Senior Center of Elk Grove, and improvements to the new Elk Grove Food Bank facility.

The release of this notice is one of the City's activities to fulfill citizen participation requirements. Federal regulations require localities to provide the public with reasonable access to the documents.

The CAPER is available for public review at the Elk Grove City Hall, 8401 Laguna Palms Way; the Elk Grove Public Library, 8900 Elk Grove Boulevard; and the Elk Grove Senior Center, 8830 Sharkey Avenue. The CAPER is also available for public review on the City Planning Division's website at <http://www.egplanning.org/housing/cdbg.asp>

Copies of the CAPER will be made available upon request and are free of charge.

The public review and comment period begins August 25, 2010 and will end September 08, 2010. The City of Elk Grove City Council will consider adoption of the CAPER and provide an opportunity for public comment at their September 08, 2010 meeting.

The City of Elk Grove encourages interested parties to attend public meetings and comment on the issues being discussed. If you wish to provide testimony and are unable to attend the meeting, written comments that are delivered to the City Clerk's office prior to the time of the hearing will be made a part of the public record.
