RECOMMENDATION:

- 1) Adopt A Resolution Of The City Council Of The City Of Elk Grove Stating The City's Intention Regarding Ordinance No. 20-2005; and
- 2) Waive The Full Reading By Substitution Of Title Only, An Urgency Ordinance Amending Ordinance 20-2005 Of The City Of Elk Grove Relating To Parks, Clarifying The Intent And Operation Of Ordinance 20-2005 As It Relates To Landscape Medians; and
- 3) Adopt An Urgency Ordinance Amending Ordinance 20-2005 Of The City Of Elk Grove Relating To Parks, Clarifying The Intent And Operation Of Ordinance 20-2005 As It Relates To Landscape Medians

City Attorney Manzanetti provided an overview of the staff report and recommended action.

Mayor Briggs opened the public comment opportunity.


ADJOURNMENT
