

**RESOLUTION NO. 2009-186**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH THE  
COUNTY OF SACRAMENTO TO PROVIDE HAZARDOUS MATERIALS RESPONSE  
SERVICES TO THE CITY OF ELK GROVE AS WELL AS PROVIDE THE CITY OF  
ELK GROVE MUTUALLY AGREEABLE PERFORMANCE MEASURES AND/OR  
STATISTICS WITH EACH BILL**

**WHEREAS**, the County of Sacramento has requested the City of Elk Grove pay their fair share of costs related to hazardous materials response services within the incorporated limits of Elk Grove; and

**WHEREAS**, the County of Sacramento has prior agreements directly with the City of Sacramento Fire Department and the Sacramento Metropolitan Fire District for these services; and

**WHEREAS**, the level of service for hazmat response will remain constant with the approval of this agreement; and

**WHEREAS**, the prior agreement was from July 1, 2004 and ended on June 30, 2009; and

**WHEREAS**, it is necessary to enter into a new agreement for this service so the City is protected in the event of a hazardous incident in the City; and

**WHEREAS**, due to the regional nature and time sensitivity of the agreement, the City will sign the agreement without defined performance measures and work with the County to establish mutually agreeable performance measures and/or statistics that meet the needs of the City prior to the first bill.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to enter into an agreement with the County of Sacramento to provide hazardous materials response services to the City of Elk Grove as well as provide the City of Elk Grove mutually agreeable performance measures and/or statistics with each bill.


