**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A MEMORANDUM
OF UNDERSTANDING AND FIRST CONTRACT AMENDMENT WITH
INTERGRAPH CORPORATION FOR PROFESSIONAL SERVICES
AND SOFTWARE LICENSE AGREEMENT**

WHEREAS, the City entered into Contract No. C-06-047 with Intergraph Corporation for the purchase and installation of a law enforcement computer system in 2006; and

WHEREAS, the City's law enforcement computer system requires periodic updates, upgrades, and maintenance to ensure efficiency and accuracy; and

WHEREAS, it is necessary to clarify the terms, conditions, and definitions contained in Contract No. C-06-047 to ensure the City's law enforcement computer system is maintained in the manner expected by City staff; and

WHEREAS, it is in the best interest of the City to provide clarity and understanding by amending Contract No. C-06-047 and setting forth a Memorandum of Understanding that will provide the framework for future updates, upgrades, and maintenance to the City's law enforcement computer system.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a Memorandum of Understanding and First Amendment to Contract No. C-06-047 with Intergraph Corporation for Professional Services and Software License Agreement.


