

RESOLUTION NO. 2010-23

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE MAYOR TO EXECUTE A LANDSCAPE MAINTENANCE
AGREEMENT WITH THE COSUMNES COMMUNITY SERVICES DISTRICT**

WHEREAS, the City of Elk Grove (City) and the Cosumnes Community Services District (CCSD) entered into a Memorandum of Understanding and Settlement Agreement (Agreement) on August 15, 2007; and

WHEREAS, the Agreement required both parties to work cooperatively in the ongoing development, acquisition of land, collection of fees and exactions related to new facilities as well as the maintenance and operations of both new and existing facilities; and

WHEREAS, the Agreement required the CCSD maintain status quo for a period of two years after the execution of the agreement; and

WHEREAS, the CCSD has continued to operate under the same conditions past the expiration of the status quo requirement pending final execution of a comprehensive landscape maintenance agreement with the City; and

WHEREAS, the City and CCSD staff have cooperated for many months in the development of a comprehensive landscape maintenance agreement; and

WHEREAS, all direct and indirect costs have been considered in drafting the landscape maintenance agreement which provides revenue neutrality for both parties if not significant savings; and

WHEREAS, the landscape maintenance agreement, as drafted, is anticipated to bring many benefits to the City and the CCSD, which will ultimately benefit the Citizens of Elk Grove.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the Mayor to execute a landscape maintenance agreement with the CCSD to perform landscape maintenance services throughout the City.


