**WHEREAS**, the City Council adopted the Historic Preservation Ordinance, Elk Grove Municipal Code (EGMC) Chapter 7.00, on January 24, 2007; and

**WHEREAS**, EGMC Chapter 7.00 establishes the Historic Preservation Committee and its' duties, one of which is attaining and maintaining Certified Local Government (CLG) status; and

**WHEREAS**, the City has taken steps to proactively preserve its historic resources such as pursuing designation as a Preserve America Community; and

**WHEREAS**, the process to attain CLG status and fiscal impacts of said designation has been reviewed by the City Council.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the submittal of an application to the State Office of Historic Preservation seeking to approve the City of Elk Grove as a Certified Local Government.
