

**RESOLUTION NO. 2010-32**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
ACCEPTING THE I-5 / ELK GROVE BOULEVARD NORTHBOUND ON-RAMP  
IMPROVEMENTS PROJECT AS COMPLETE AND AUTHORIZING THE CITY  
ENGINEER TO PREPARE, AND THE CITY CLERK TO FILE, THE NOTICE OF  
COMPLETION WITH THE SACRAMENTO COUNTY RECORDER**

**WHEREAS**, on August 18, 2009, the City Manager, under authority of City Council Resolution No. 2009-147, authorized the award of a federal economic stimulus funded construction contract to Western Engineering Contractors to construct the I-5 / Elk Grove Boulevard Northbound On-Ramp Improvements Project (Capital Improvement Project ID PT00986) (Federal Project ID ESPL 5479 (024)) (Project); and

**WHEREAS**, the Project provided for an operational change and relocation of the High Occupancy Vehicle configuration for the northbound on-ramp from Elk Grove Boulevard to Interstate 5, including new vehicle monitoring signals and both regulatory and informational signs; and

**WHEREAS**, Western Engineering Contractors has completed the work in accordance with the contract documents for the Project; and

**WHEREAS**, Caltrans has provided new lane striping, pavement markings and partial repaving of the ramp as its contribution to the Project; and

**WHEREAS**, if no liens or claims have been filed within 35 days of filing the Notice of Completion, the retained payment funds and any remaining amount due will be released to Western Engineering Contractors.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby accepts the Project as complete.

**BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare a Notice of Completion and the City Clerk to file the Notice of Completion for the Project with the Sacramento County Recorder.


