

**RESOLUTION NO. 2010-41**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXPEND \$64,500 FROM THE TREE  
MITIGATION FUND FOR THE SACRAMENTO TREE FOUNDATION NATURE  
PROGRAM TREE PLANTINGS**

**WHEREAS**, Elk Grove Municipal Code Chapter 19.12.220 establishes a tree preservation fund, officially titled the Tree Mitigation Fund; and

**WHEREAS**, the purpose of the Tree Mitigation Fund is to fund tree planting efforts, tree preservation programs, and public education programs regarding trees; and

**WHEREAS**, the Sacramento Tree Foundation has presented a proposal to the City to implement native oak tree planting projects as part of its Native Trees in Urban and Rural Environments (NATURE) Program; and


**WHEREAS**, the Cosumnes Community Services District supports the proposed plantings; and

**WHEREAS**, oak tree planting projects are consistent with the provisions of the Tree Mitigation Fund and the Greenprint program; and

**WHEREAS**, the City of Elk Grove desires to expend tree mitigation funds for the Sacramento Tree Foundation NATURE Program tree plantings.

**NOW, THEREFORE, BE IT RESOLVED**, that the City Council of the City of Elk Grove authorizes the City Manager, or her designee, to expend \$64,500 from the Tree Mitigation Fund for the Sacramento Tree Foundation NATURE Program Tree Plantings.


