### **Marijuana Growing Operations Located**

**ELK GROVE, CA** – On September 19, 2007, the Elk Grove Police Department along with members of the California Highway Patrol and the Sacramento Police Department served search warrants in Elk Grove and surrounding areas related to marijuana cultivation.

For the past ten months, the Elk Grove Police Department Street Crimes Unit has been conducting a long term intensive investigation into a group of individuals responsible for multiple indoor marijuana cultivation locations in Elk Grove, Sacramento and Galt.

Warrants were served at twenty-one (21) locations and approximately 6,800 marijuana plants were recovered along with approximately thirty-six (36) pounds of processed marijuana. In addition, fifteen (15) arrests were made and over \$200,000 in U.S. currency along with ten (10) vehicles were seized.
