WHEREAS, §51245 of the California Government Code provides for the non-renewal of such contracts by the landowner no less than ten years from the effective date of the contract; and

WHEREAS, on February 28, 1974, the Souza Dairy Limited Partnership entered into Land Conservation Contract Number 74-AP-043 on lands described in the attached legal description; and

WHEREAS, Anthony Souza, on behalf of the Souza Dairy Limited Partnership, filed with the City of Elk Grove a Notice of Non-Renewal on a portion of the land that is subject to the provisions of Land Conservation Contract Number 74-AP-043.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ELK GROVE HEREBY RESOLVES AS FOLLOWS:


