RESOLUTION NO. 2003-151

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE TO VACATE A RIGHT-OF WAY EASEMENT AND A PUBLIC UTILITY EASEMENT OVER PORTIONS OF ELK GROVE-FLORIN AND BOND ROADS (ABANDONMENT PROCEEDING NUMBER EG-00-003)

WHEREAS, the City of Elk Grove received a petition to vacate from owners of property within the City of Elk Grove requesting the City Council of the City of Elk Grove to consider vacation of the subject property; and

WHEREAS, a notice that the City Council of the City of Elk Grove would consider the proposed vacation at a Public Hearing was given in compliance with California Streets and Highways Code, Section 8300, et. seq.; and

WHEREAS, the standards and procedures provided in the Public Streets, Highways and Service Easements Vacation Law, California Streets and Highways Code Section 8300 et seq., the City Council of the City of Elk Grove hereby declares its intention to vacate a right-of-way easement and a public utility easement over portions of Elk Grove-Florin and Bond Roads specifically shown on the attached Exhibits; and

WHEREAS, the City of Elk Grove Planning Department has reviewed this project and is recommending that the City Council of the City of Elk Grove find the vacation of the right-of-way easement and public utility easement over portions of Elk Grove-Florin and Bond Roads exempt from the provisions of the California Environmental Quality Act (CEQA) under Section 15305 of the CEQA Guidelines; and

WHEREAS, the City of Elk Grove Planning Department has determined that the vacation is consistent with the general plan and all elements thereof.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Elk Grove, a political subdivision of the State of California that this City Council hereby finds as follows:

- a. That vacation would be consistent with, and not violate the General Plan and all elements and components thereof for the City of Elk Grove; and
- b. That the right-of-way is unnecessary for present or prospective public use because the existing and remaining right-of-way will provide public access to all lots; and
- c. That the public interest will be served by the herein vacation; and
- d. Grant in fee simple the excess right-of-way to the adjoining property owners.

BE IT FURTHER RESOLVED AND ORDERED that the right-of-way easement and public utility easement over portions of Elk Grove-Florin and Bond Roads as shown in the Exhibits are hereby vacated.

BE IT FINALLY RESOLVED AND ORDERED that the City Clerk of the Elk Grove City Council shall cause a certified copy of this Resolution of Vacation, attested by the Clerk under seal, to be recorded in the office of the Recorder of the County of Sacramento.
