A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A CONSULTANT SERVICES CONTRACT WITH WILLDAN FINANCIAL SERVICES, INC. FOR SOLID WASTE RATE PROJECTIONS SERVICES RELATED TO THE TRANSFER STATION LONG RANGE PLANNING PROJECT (SW0001) IN THE AMOUNT OF \$99,000

WHEREAS, the City published a Request for Proposals (RFP) for Solid Waste Rate Setting and Audit Consultant Services on May 22, 2009; and

**WHEREAS**, two responses to the RFP were received by R3 Consulting Group, Inc. and Willdan Financial Services, Inc.; and

WHEREAS, a review committee made up of five different public agency representatives from the Sacramento region interviewed the two applicants and determined that each offered different strengths that neither possessed entirely on their own, so the committee elected to divide the tasks between each firm; and

WHEREAS, Willdan Financial Services, Inc. has partnered with Waste Systems Technology to provide specialized solid waste facility development expertise necessary for their services.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a Consultant Services contract with Willdan Financial Services, Inc. for solid waste rate projections service related to the Transfer Station Long Range Planning Project (SW0001) in the amount of \$99,000.
