- 4.4.3 Plinth for Music Sculpture Lana is working to obtain quotes as this is a Public Works project.
- 4.4.4 Blues Festival- Nan presented the idea of a Blues Festival. After some discussion the Commissioners decided their focus would be better spent on this Festival and to no longer hold the Iris Awards on May 23, 2024. Tentative date for the Festival will be Sunday, July 21, 2024 at District56. Nan will work to find Blues bands and would like to continue the discussion regarding this event on the next agenda.
- 4.4.5 Repair of Utility Box Wrap at Lotz/Big Horn Lana is waiting for quotes back from The Sign Center.
- 4.4.6 Possible Mural at 9300 Elk grove Florin Rd. Cheryl was absent and unable to report on this, however, notes were provided from Lana that mentioned the retaining wall at this location is private property and the City is unable to utilize public funds to enhance the property.
