#### 5. PUBLIC HEARING ITEMS:

- 5.1 **2014-2019 CAPITAL IMPROVEMENT PROGRAM (CIP) – GENERAL PLAN CONFORMANCE:** The City of Elk Grove's CIP is a five-year program consisting of two primary purposes; 1) the CIP describes transportation, drainage, and facility capital improvements planned by the City; and 2) it sets forth a funding strategy for their implementation. The Planning Commission reviews annually the Capital Improvement Program for conformance to the City's General Plan.

**Recommendation:** Deem the CIP program consistent with the City of Elk Grove's General Plan.

**5.2 ZONING CODE UPDATE:** An amendment to Title 23 of the Elk Grove Municipal Code to; (1 remove the requirement for a legal description for Special Planning Areas; (2 update the findings for Special Planning Areas; and (3 establish a process for establishing and amending Community Plans.

**Recommendation:** *Recommend to the City Council that no further review from CEQA is required and approval of the amendments.*
