**NOTICE** is hereby given pursuant to Section 54955 of the Government Code, that on **January 20, 2010**, the Planning Commission of the City of Elk Grove held a Public Hearing at the **Elk Grove City Hall, located at 8400 Laguna Palms Way, Elk Grove, to consider the following item. The following hearing was continued to the March 3, 2011** Regular Planning Commission Meeting.

### AMENDMENTS TO TITLE 23 (ZONING) – CITY-INITIATED ORDINANCE

**REQUEST:** The proposed City-initiated amendments to Title 23 (Zoning) of the Elk Grove Municipal Code include amendments to simplify the development review process, to comply with state and federal laws, and to implement the City's Housing Element that was certified in 2009. The proposed amendments include revisions to the City's signage regulations, the design review process, allowed use definitions, allowed use tables, big box retail architectural design standards, wireless facilities, and Planning Director authority, and proposes several new permits including a Reasonable Accommodations permit and a Parking Reduction permit. Additional items have been added since the December 16, 2010 Planning Commission meeting including, but not limited to, allowed use regulations for alcohol sales and other topics as the Planning Commission may identify at the meeting within Title 23.
