RESOLUTION NO. 2000-45

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE ELECTING TO BE SUBJECT TO PUBLIC EMPLOYEE'S MEDICAL AND HOSPITAL CARE ACT AND FIXING THE EMPLOYER'S CONTRIBUTION AT AN AMOUNT GREATER THAN THAT PRESCRIBED BY SECTION 22850 OF THE GOVERNMENT CODE

WHEREAS, government Code Section 22850 extends the benefits of the Public Employees' Medical and Hospital Care Act to employees to contracting agencies on proper application by an agency; and

WHEREAS, the Government Code Section 22754 (g) defines any Special District as a contracting agency, and

WHEREAS, a Special District is hereby defined as a self-governed public agency within the State of California, and comprised solely of public employees performing a governmental rather than proprietary functions, and

WHEREAS, the City of Elk Grove hereinafter referred to as Special District is an entity meeting the above mentioned definition; and

WHEREAS, the Special District desires to obtain for its employees, retired employees, and survivors the benefit of the Act and to accept the liabilities and obligations of an employer under the Act and Regulations.

RESOLVED, that the Special District hereby elects to be subject to the provisions of the Act; and be it further

RESOLVED that the employer's contribution for each employee or annuitant shall be the amount necessary to pay the full cost of his/her enrollment, including the enrollment of family members, in a health benefits plan or plans up to a maximum of \$16 dollars per month plus administrative fees and Contingency Reserve Fund assessments; and be it further

RESOLVED that the executive body appointment and direct, and it does hereby appoint and direct, the City Manager to file with the Board of Administration of the Public Employees' Retirement System a verified copy of this Resolution, and to perform on behalf of said Special District all functions required of it under the Act and Regulations of the Board of Administration; and be it further

RESOLVED that coverage under the Act be effective on January 1, 2001.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby elects to be subject to the provisions of the Act; and
