

RESOLUTION NO. 2004-151

A RESOLUTION OF THE COUNCIL OF THE CITY OF ELK GROVE APPROVING THE REVISED SCHEDULE OF PARKING VIOLATION FINES AND PENALTIES IN COMPLIANCE WITH CALIFORNIA VEHICLE CODE SECTION 40203.5

WHEREAS, California Vehicle Code Section 40203.5 provides for cities to establish the amount of parking fines; and

WHEREAS, Vehicle Code Section 40203.5 authorizes the City to recover administrative fees, process service fees, collection costs related to civil debt collection, late payment penalties, and other related charges; and

WHEREAS, State Law requires the City to include penalties imposed by the County of Sacramento for jail and courthouse construction in accordance with Government Code Sections 76000 and 76101; and

WHEREAS, the Council adopted the County-wide schedule of parking fines and penalties by Resolution, dated August 26, 2003; and

WHEREAS, the Police Department desires to amend the schedule of parking fines and penalties to show fine amounts by City Code or California Vehicle Code violation; and

WHEREAS, the proposed revised Parking Violation Fine Schedule (Attachment A) sets out parking violations and fines within the City's authority, adjusts certain fines to comply with Vehicle Code limits.


NOW THEREFORE, City Council of the City of Elk Grove hereby adopts the Parking Violation Fine Schedule (Attachment A) with fines as previously set and with adjustments in compliance with the Vehicle Code effective immediately.



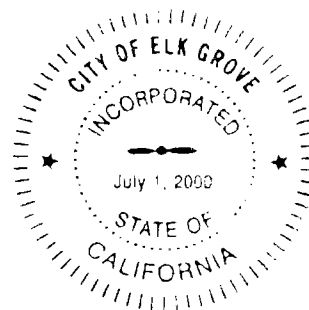
