RESOLUTION NO. 2004-293

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AMENDING THE 2004-2005 FISCAL YEAR BUDGET TO AMEND SALARY RANGES TO SUGGESTED COMPENSATION LEVELS. ADD FOUR NEW POSITIONS, RECLASSIFY THREE POSITIONS AND TO APPROPRIATE FUNDS TO PROVIDE FOR THE NEW POSITIONS AND RECLASSIFICATIONS

WHEREAS, the City Council recognizes the need for a reclassification of three positions to best serve the City: The Intergovernmental Relations Officer position to Director of Communications (to salary range E203); the Finance Administrator position to Director of Finance (to salary range E203); and the General Project Coordinator to Contract Compliance Administrator (to salary range M132); and

WHEREAS, the City Manager recommends that these three positions be reclassified to serve the City's needs; and

WHEREAS, the City Council recognizes the need to add four positions to best serve the City: Chief Operating Officer (the salary range of E237), Deputy City Manager (the salary range of M134), Senior Management Analyst (the salary range of E184), and Management Analyst (the salary range of E174); and

WHEREAS, the City Manager recommends that these four positions be created to provide the additional support needed at the City.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Elk Grove that the 2004-2005 Fiscal Year Budget be amended to amend the salary structure of those positions listed in Exhibit 1, reclassify and add the aforementioned positions and appropriate \$285,000 from the General Fund to provide funding for these reclassified and new positions for the remainder of the 2004-05 fiscal year.
