RESOLUTION NO. 2004-306

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE APPROVING AN INCREASE IN THE CORPORATION YARD PROJECT BUDGET FROM \$5.5 TO \$7.3 MILLION TO PROVIDE FUNDING FOR ALL SITE AND TENTANT IMPROVEMENTS

WHEREAS, the City Council approved the purchase of the building and property known as the Corporation Yard located at 10250 Iron Rock Way; and

WHEREAS, the building was purchased for Transit Operations, Public Works services, fleet vehicle parking and maintenance services, and future City growth demands; and

WHEREAS, various items to be improved are listed as: parking lot, security, building, technology, warehouse, furnishings, etc...; and

WHEREAS, said improvements are necessary to provide for a fully functional corporation yard that meets State and Federal regulations; and

WHEREAS, in order to provide sufficient funding for the site and tenant improvements it is necessary to amend the budget to allow for the appropriation of funds not included in the Fiscal Year 2003-04 budget.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby approves a budget amendment to the Corporation Yard Capital Improvement (PF0001) by increasing the budget by \$1.8 million.

NOW, THEREFORE, BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby approves that the entire Corporation Yard budget will be funded according to the following revenue sources: approximately 59% of the cost, approximately \$4.3 million, will be funded by the corporation yard component of the capital facilities development impact fee. Another \$610,000 will be funded from the CFD 2003-1 bond proceeds related to that area's benefit from the facilities, and the remainder of the cost will be allocated to the funds benefiting from the improvements based on their usage of the facilities – including the transit fund (fund 511), storm drainage fund (fund 503), gas tax fund (fund 221), solid waste (fund 501), and approximately \$195,000 from to the general fund.
