A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY ENGINEER TO PROCEED WITH PROCUREMENT OF INTELLIGENT TRANSPORTATION SYSTEMS EQUIPMENT AND SERVICES

WHEREAS, the City supports the goal of managing traffic congestion, reducing delay, and improving traffic safety; and

WHEREAS, the City's Intelligent Transportation Systems (ITS) Master Plan identifies various improvements and programs needed to modernize the City's traffic control system; and

WHEREAS, the traffic signal system and controller industry is a very specialized field with a very small number of suppliers of central system hardware, software, and compatible field controllers; and

WHEREAS, these suppliers are generally the sole providers of training, technical support, and integration services for their equipment; and

WHEREAS, it is essential that all traffic control equipment be compatible with the central system to achieve full functionality of the overall traffic control system; and

WHEREAS, the purchase of certain ITS equipment and services therefore does not fit a typical competitive bid process due to the unique nature of the equipment and services; and

WHEREAS, the City has conducted a qualifications and performance-based evaluation of alternative systems, including fulfillment of City functional requirements, interviews, live demonstrations, reference checks, and cost analyses; and

WHEREAS, the City has determined that the Naztec Streetwise TM system and related equipment, distributed and supported by Western Pacific Signal, LLC, will best meet the needs of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to proceed with procurement of Intelligent Transportation System equipment and services from Western Pacific Signal, LLC.
