RESOLUTION NO. 2005-248

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE APPROVING AND ESTABLISHING A FEE SCHEDULE REGARDING THE PROVISION OF ANIMAL SERVICES BY AND FOR THE CITY

WHEREAS, the City of Elk Grove ("City") has terminated the City's Agreement with the County of Sacramento for Animal Care and Regulation Services, including termination of the County's right to collect animal license, shelter and related fees on the City's behalf as of September 1, 2005; and

WHEREAS, as of September 1, 2005, the City will be administering and providing animal control field services within the City through the City's Department of Animal Services; and

WHEREAS, as of September 1, 2005, the Sacramento Society for the Prevention of Cruelty to Animals ("Sacramento SPCA") will be providing animal shelter and related services to the City for the impoundment, relinquishment, quarantine and adoption or sale of animals pursuant to the Master Services Agreement executed by and between the City and the Sacramento SPCA on February 16, 2005; and

WHEREAS, pursuant to the City's agreement with the Sacramento SPCA, the Sacramento SPCA is authorized to license animals belonging to City residents, as required by law, when necessary, including rabies inoculations; and

WHEREAS, it is the City's intent that all licenses issued for animals within the City prior to September 1, 2005 remain in full force and effect until their expiration; and

WHEREAS, the City desires to establish a comprehensive schedule of fees relating to the provision of animal services by and for the City, which fees shall be effective September 1, 2005.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Elk Grove that:

- 1. <u>Section 1</u>. <u>Recitals</u>. The foregoing recitals are true and correct and this Council so finds and determines.
- 2. <u>Section 2</u>. <u>Purpose</u>. Fees for animal services provided by and for the City shall adhere to the amounts established by this Resolution.
- 3. <u>Section 3.</u> <u>Schedule of Fees.</u> All licenses issued by the County for animals within the City prior to September 1, 2005, shall remain in full force and effect until their expiration. The following schedule sets forth fees for animal services provided by or for the City. The fees set forth below may be amended or modified at any time by the City Council, by subsequent resolution.
