## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY ENGINEER TO SIGN AND SUBMIT PROJECT APPLICATIONS FOR THE SACRAMENTO AREA COUNCIL OF GOVERNMENTS' GRANT PROGRAMS ON BEHALF OF THE CITY OF ELK GROVE

WHEREAS, the Sacramento Area Council of Governments' (SACOG) Board of Directors approved the process and schedule for distributing approximately \$150 million in pooled state and federal funds for various transportation projects throughout the SACOG region; and

WHEREAS, the process calls for distributing the funds under the following seven programs: Identified Regional-Scale Projects, Community Design, Transportation Demand Management, Air Quality, Bicycle and Pedestrian, Road Rehabilitation, and locally-identified projects; and

**WHEREAS**, the Two Gasoline Hybrid Bus Acquisition Project and the 10 Heavy-Duty Diesel Bus Replacement with New Flyer Hybrids are eligible to be funded through the Air Quality Program; and

WHEREAS, the Bicycle Amenities at Bus Stops Project and the Elk Grove Creek/State Route 99 Trail Crossing Project are eligible to be funded through the Bicycle and Pedestrian Program; and

**WHEREAS**, the Transit Bus Stop Amenities Project is eligible to be funded through the Community Design Program; and

WHEREAS, the State Route 99/Sheldon Interchange, State Route 99/Grant Line Road Interchange, Grant Line Road Widening and Grade Separation (from East Stockton Boulevard to Bradshaw), Kammerer Road Extension (from Bruceville Road to Interstate 5) and Interstate 5/Hood Interchange, State Route 99/Elk Grove Boulevard Interchange Modifications, Bradshaw Road Widening (from Calvine Road to Grant Line Road), and Elk Grove Train Stop are eligible for the Regional-Scale Projects Program and the Locally Identified Projects Program; and

**WHEREAS**, the Elk Grove Rehabilitation of various city streets is eligible to be funded through the Local Road Rehabilitation Program; and

**WHEREAS**, SACOG requires that copies of grant applications and/or information also be submitted to the Sacramento Transportation Authority (STA).

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Engineer to sign and submit project grant applications to SACOG and the STA for the aforementioned projects on behalf of the City of Elk Grove.
