RESOLUTION 2006-48

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER, OR HIS DESIGNEE, TO EXECUTE REAL ESTATE AGREEMENTS AND RELATED DOCUMENTS FOR THE ACQUISITION OF RIGHT-OF-WAY FOR THE GRANT LINE ROAD WIDENING PROJECT

WHEREAS, improving Grant Line Road holds a high priority in the City of Elk Grove Transportation Improvement Program and acquiring the necessary right-of-way is an important and necessary step in meeting the goals set forth in the General Plan for the Grant Line Road Widening Project; and

WHEREAS, the Grant Line Road Project involves replacing the current two-lane facility with a six-lane facility from East Stockton Boulevard to Waterman Road; replacing the existing two lanes to four lanes from Waterman Road to Bradshaw Road; installing traffic signals and intersection improvements at Waterman Road and Bradshaw Road; and constructing an over-crossing at the Union Pacific railroad (UPRR) tracks. To construct these improvements, property interests affecting approximately 18 property owners are required, as identified on the attached Exhibit 1; and

WHEREAS, the City shall follow the Land Acquisition Procedures as set forth by the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 and its various amendments and the State of California, Department of Housing and Community Development, adopted Title 25 of Chapter 6 of the California Code of Regulation.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager, or his designee, to execute all contracts and documents for the acquisition of right-of-way and real property interests for those properties affected by the Grant Line Road Widening Project as listed on the attached Exhibit 1, for which the total compensation shall not exceed \$6,150,000.

BE IT FURTHER RESOLVED that up to \$19,399,000 may be advanced to the subject project from the Elk Grove Roadway Fee Program, with any monies advanced to be repaid by developments adjacent to the project as they occur.
