

Resolution No. 2006-223

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
FOR PAYING AND REPORTING THE VALUE OF
EMPLOYER PAID MEMBER CONTRIBUTIONS**

WHEREAS, the governing body of the City of Elk Grove has the authority to implement Government Code Section 20636(c) (4) pursuant to Section 20691; and

WHEREAS, the governing body of the City of Elk Grove has a written labor policy or agreement which specifically provides for the normal member contributions to be paid by the employer, and reported as additional compensation; and

WHEREAS, one of the steps in the procedures to implement Section 20691 is the adoption by the governing body of the City of Elk Grove of a resolution to commence paying and reporting the value of said Employer Paid Member Contributions (EPMC); and


WHEREAS, the governing body of the City of Elk Grove has identified the following conditions for the purpose of its election to pay EPMC:

- This benefit shall apply to all employees of miscellaneous class.
- This benefit shall consist of paying 8% of the normal member contributions as EPMC, and reporting the same percent (value) of compensation earnable* (excluding Government Code section 20636(c) (4)) as additional compensation.
- The effective date of this resolution shall be 5/24/2006.

NOW, THEREFORE BE IT RESOLVED AND ORDERED, that the governing body of the City of Elk Grove elects to pay and report the value of EPMC, as set forth above.

BE IT FURTHER RESOLVED, that Resolution No. 2006-124 is superseded with adoption of this resolution.




