

Resolution No. 2006-247

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DETERMINING TO LEVY STREET MAINTENANCE ASSESSMENTS IN STREET
MAINTENANCE DISTRICT NO. 1
(Zone 4 [Northeast Franklin] – Annexation No. 2)**

WHEREAS, on August 9, 2006, the City Council (the "City Council") of the City of Elk Grove (the "City") adopted Resolution No. 2006-212 (the "Resolution of Intention") determining to undertake proceedings pursuant to the Benefit Assessment Act of 1982, being California Government Code sections 54703 *et seq.* (the "Act"), to levy assessments to finance costs of maintaining streets and roads within the territory proposed to be added to Street Maintenance District No. 1 (the "District") that is located within a zone of benefit referred to as "Zone 4";

WHEREAS, in accordance with the Act, a Supplemental Engineer's Report (Supplement No. 2), which supplements the Engineer's Report for Zone 4 of the District originally submitted on May 11, 2005, and supplemented by Supplement No. 1 on September 28, 2005 (collectively, the "Engineer's Report") was prepared by Pacific Municipal Consultants and City Engineer, filed with the City Clerk, and preliminarily approved by this Council by the Resolution of Intention;

WHEREAS, this Council fixed 6:30 p.m. (or as soon thereafter as the matter may be heard) on Wednesday, September 27, 2006, at City Hall, 8400 Laguna Palms Way, Elk Grove, California, as the time and place for a public hearing on the Engineer's Report as supplemented by Supplement No. 2 and the question of levying the assessments and provided for notice of the hearing;

WHEREAS, this Council hereby finds that a notice of the time and place for the public hearing has been published for two successive weeks in *The Elk Grove Citizen*, mailed to the record owner of each identified parcel within the boundaries of the territory proposed to be added to the City of Elk Grove Street Maintenance District No. 1, and posted in three public places in the City in the time, form, and manner required by law;

WHEREAS, the public hearing was duly convened by this Council at the time and place indicated in the notice of public hearing and all protests received by the City Clerk were presented to the Council;

WHEREAS, this Council thereupon proceeded with the public hearing and duly heard all interested persons desiring to be heard and duly considered all of the protests at the hearing; and

WHEREAS, at the time of the close of the public hearing, the ballots (all ballots weighted according to the proportional financial obligation of each affected property) submitted in opposition to the proposed assessment did not exceed the ballots submitted in favor of the assessment.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Elk Grove that:

1. **Recitals.** The foregoing recitals are true and correct and this Council so finds and determines.

2. **Final Approval of Engineer's Report.** This Council hereby approves the Supplement No. 2, which incorporates by reference the original Engineer's Report, as now on file with it.


3. **Benefit Finding.** This Council hereby finds and determines that the assessment included in the Engineer's Report as supplemented by Supplement No. 2 assesses all assessable lots or parcels described therein in proportion to the benefits to be received by each affected parcel, respectively, from the maintenance of roads and streets.

4. **Determination of Assessment.** This Council hereby determines that it will levy the assessment as described in the Engineer's Report as supplemented by Supplement No. 2.

5. **Directive to Record and File Documents.** This Council hereby directs the City Clerk to record the assessment diagram and the assessment roll in her office and to file the assessment diagram and record the notice of assessment in the office of the Sacramento County Recorder.


6. **Effective Date.** This resolution shall take effect from and after the date of its passage.


