

RESOLUTION NO. 2006-253

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE ACCEPTING THE ASPHALT CONCRETE OVERLAY AND CURB RAMP IMPROVEMENTS PROJECT 2006 AS COMPLETE AND AUTHORIZING THE CITY ENGINEER TO PREPARE THE NOTICE OF COMPLETION AND THE CITY CLERK TO FILE THE NOTICE OF COMPLETION WITH THE SACRAMENTO COUNTY RECORDER

WHEREAS, on May 10, 2006, the City Council authorized the award of a contract to Teichert Construction to perform the Asphalt Concrete Overlay and Curb Ramp Improvements Project 2006; and

WHEREAS, the contract called for overlaying asphalt concrete on various streets in the City as part of the City's resurfacing program and constructing curb ramp improvements within the overlay limits to enhance pedestrian accessibility and safety and meets the requirements of the Americans with Disabilities Act and California Code of Regulations Title 24; and


WHEREAS, Teichert Construction has completed the work in accordance with the contract for the Asphalt Concrete Overlay and Curb Ramp Improvements Project 2006; and

WHEREAS, if no liens or claims have been filed within 35 days of filing the Notice of Completion, retention and any remaining amount due will be released to Teichert Construction.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby accepts the Asphalt Concrete Overlay and Curb Ramp Improvements Project 2006 as complete.


BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Engineer to prepare the Notice of Completion and the City Clerk to file the Notice of Completion for the Asphalt Concrete Overlay and Curb Ramp Improvements Project 2006 with the Sacramento County Recorder.
